Investment Guidelines:

In accordance with Section 2925 of the Public Authorities Law, the GGLDC is required to adopt Investment Guidelines which detail its operative policy and instructions to staff regarding the investing, monitoring and reporting of funds of the Agency. In addition, the GGLDC is subject to the deposit and investment restrictions contained in Sections 10 and 11 of the General Municipal Law.

The Investment Guidelines were approved by the GGLDC Board on June 2, 2022 and are posted on the GGLDC website at http://www.gcedc.com/news/local-development-corp-ggldc/ggldc-reports. The Investment Guidelines are consistent with the prior Guidelines adopted on June 3, 2021.

Investment Audit:

The auditors for the GGLDC have audited the corporation's compliance with the Investment Guidelines for Public Authorities. In their report dated March 30, 2022 Mostert, Manzanero & Scott, LLP indicated that the Agency complied, in all materials respects, with these Investment Guidelines.
